Essence Health Specialized College is a newly established higher learning institution, wholly owned by two young Namibian women who are registered nurses by profession and passionate about developing the Namibian youth by enabling them, through quality and affordable education, to further their studies in the field of nursing and allied health.

Our ultimate objective for the allied health courses is to bridge the gap between secondary and tertiary education by giving hope to a young Namibian child who have failed grade 10 or grade 12 and would like to pursue a career in nursing, to be accepted into Nursing schools through the Recognition of Prior Learning (RPL) program as set out in the National Policy on RPL.

The College is located in **Ondangwa town** at **Erf 1643, Omukwiyu Complex, Ondangwa, Oshana Region** and is registered under the registration number of **Close Corporation CC/2019/08699, P O Box 4270, Main branch, Windhoek, Namibia, 9000**. We opened our doors in Ondangwa, on the 20th of January 2020.

Our courses comprise of both theoretical and practical exposure as we want our students to gain enough practical knowledge to set them apart for the job market and articulation into nursing education. SPECIAL INSTRUCTIONS TO ALL NURSING STUDENTS

1. Attendance of Lectures

Students must comply with 100% class attendance (up to 80% accepted with valid absence proof) and 100% practical attendance. In order to obtain registration with the Health Professions Council of Namibia, students must comply with theory and practice requirements as stated by the Nursing Council.

2. Clinical Allocation/Placement

2.1.General Information

- The student nurse must work under direct or indirect supervision of qualified personnel when doing practical work, for example, registered nurses, doctors, pharmacists, dieticians, etc.
- Lectures are be given during the normal working day, Monday to Friday, between 07:30 – 16:00.
- Practical work covers a 24 – hour working period. Students should expect to be allocated night and day shifts.
- Students will be allocated to any government health facility across the country that is accredited by the Health Professions Council of Namibia and have opportunity to receive the student.
- Hospital orientation is required upon the initial clinical placement. All students are required to attend the orientation.
- Nursing students shall conform to prescribed registrations with the Nursing Council and all applicable legislations/regulations as per relevant ordinances.
- Nursing modules consists of compulsory clinical practice which counts for 50% of the modules.
- Clinical placement in training hospitals will commence from the first Year of training and will run concurrently with lectures.
- The award of the qualification is subject to the satisfactory completion of the prescribed practical hours and the satisfactory completion of practical registers.
- All clinical documents are regarded as legal documents and should bear the signature of the student, the lecturer, Clinical Instructor, preceptor or registered nurse who teach the student.
- The practical hours for the Year should be completed before registering for the next academic Year.
- Procedures in the practical registers has to be signed by permanent appointed registered nurses and not newly appointed registered nurses

SPECIAL INSTRUCTIONS TO ALL NURSING STUDENTS CONT....

- on probation. All signatures of the registered nurses and lecturers/clinical instructors/preceptors should be authentic and legible by using a signature verification sheet at the end of the practical logbook.
- When a student fail a clinical module in an academic year he/she will not be allowed to register any clinical module in the following academic year in concurrence with the failed module.
- All students should adhere to the specific rules and regulations of the Ministry of Health and Social Services during their allocation in clinical areas.
- The use of cell phones during clinical practice is not allowed. This is considered highly unethical and interfering with the caring of a patient.
- All undergraduate students sign a contract about the School's Code of conduct at the beginning of their first Year of studies.

2.2. Continuous Assessment

- The pass mark for all clinical procedures is 80%.
- Each procedure for CA must be passed with a minimum 80% to qualify for examination.
- If the student fails to obtain 80 % in each practical assessment for CA mark, the student does not qualify to be admitted to both the practical and the theoretical examination of the specific module. This means the student is to repeat the module in the next academic Year.

2.3. Examination Mark

- Each examination procedure (irrespective of the number of procedures) must be passed with a minimum 80%.
- If the subminimum of 80% is not achieved in any of the procedures, the candidate fails the practical examination.
- If the student fails a procedure, they qualifies for supplementary examination for that procedure.
- Completion of the practical logbook should adhere to principles of record keeping at all times.
- No correction fluid, magic pen or pencil may be used in the practical logbook or clinical attendance register.
- In the event of any suspected fraudulent behavior (procedures signed without having been actually carried out or completed, fraudulent signatures etc.), the student will be subjected to disciplinary measures.

SPECIAL INSTRUCTIONS TO ALL NURSING STUDENTS CONT....

- Fraudulent actions are regarded as serious professional misconduct. The student will appear before the Disciplinary Committee for misconduct at the school.
- When fraud is confirmed through the College's investigation office, and based on the gravity of the fraud, the School's Disciplinary Committee may impose disciplinary sanctions as decided by the disciplinary committee, guided by the Code of Conduct for the students.

2.4. Absenteeism from Clinical Areas

- Students are expected to attend 100% of clinical practice for each allocation / block of clinical practice. No clinical Assessment will be conducted for a student with outstanding clinical hours, and this also means no student will be admitted to the examination with outstanding clinical hours. Emergency cases (sickness, death, delivery of a baby) will be considered as special cases and handled individually, provided that necessary proof is provided where applicable.
- An undergraduate nursing student who failed a module with a practical component (General Nursing Science, Midwifery Nursing Science, Mental Health Nursing Science, and Community Nursing Science) at a particular level of studies, cannot register for any modules with practice components in the subsequent Year of studies to give the same student a chance to repeat the failed module meaningfully.

2.5. Students' Registration with the Nursing Council

- All students enrolled for any of the nursing courses should be registered with the Nursing Council by paying a fee as determined by the Council for their registration as nursing students for the period of their studies. The council fee is payable upon registration with the College into the Nursing Council's bank account and provide proof of payment to the office of the Registrar. The once off payment covers the student nurse' registration at the Nursing Council for the duration of study, one year or two years or four years.
- Students shall be informed accordingly after registration with the School.

2.6. Dress Code

- Students should adhere to the dress code as agreed upon with the School.
- Students should wear full uniform of a colour prescribed/approved by the school and the prescribe epaulettes.
- Flat black shoes (no high heels/sandals or slippers).

Please Note: students are responsible to purchase their own uniform & shoes.


SPECIAL INSTRUCTIONS TO ALL NURSING STUDENTS CONT....

- Uniforms and epaulettes MUST be bought at the manufacturer recommended by the school to ensure uniformity and correct standards. Uniforms inspection will be conducted prior to clinical allocation commencement.
- Hair must not touch the shirt sleeves. If long hair, should be made into a neat bunny. Only earth or nude colors are allowed in the hairstyle.
- No long hand nails and no manicures or nail paints. This is done in keep with the infection control principles.
- Female students are expected to wear pantyhose with nude colors under a skirt, dress or trouser.
- Uniforms must be clean, neat and well-fitted; skirt or dress must be knee-length.

2.7. Equipment required for Clinical Practice

The First Year nursing students should buy the following equipment after registration and before clinical allocation commence:

- Practical Logbooks for all clinical modules including Clinical Evaluation Form
- Watch with a second hand/ Shoulder Watch
- Digital Thermometer
- Stethoscope
- Scissor (sharp/blunt 12– 15cm)
- Aneroid Baumanometer (Manual)
- Measuring tape
- A pencil
- A red, blue, and black pen
- An A5 or A6 Notebook



GENERAL REQUIREMENTS

GENERAL REQUIREMENTS:

- Grade 9 (new curriculum) or grade 10 (old curriculum) or grade 11 (new curriculum) or grade 12 (new curriculum) or AS level and a better symbol in English.

MATURE AGE ENTRY PROGRAMME

Candidates aspiring for admission to Essence Health Specialized College undergraduate Programmes through the Mature Age Entry Scheme must satisfy the following conditions:

- They should be at least 25 years old on the first day of the academic year in which admission is sought;
- They should preferably have successfully completed junior secondary; and
- They should normally have proof of at least three years' relevant work experience relating to the proposed study programme.
- The applicants will be required to submit an application form either hard copy or online application with relevant documentation via the College's website. After assessing the criteria above, eligible candidates will be invited for the Mature Age Entry Test, which will consist of three / four papers:

- a. Paper 1:** An English Test;
- b. Paper 2:** A General Knowledge Test;
- c. Paper 3:** A Numerical Ability Test;
- d. Paper 4:** A Nursing Specific Test

- Candidates who, in the opinion of the relevant Program, merit further consideration may be called for an interview before the final selection is made.



CERTIFICATE IN ENROLLED NURSING AND MIDWIFERY SCIENCE (NQF LEVEL 6)

Midwifery Science is designed to prepare students with the knowledge, skills, and professional values needed to provide quality nursing and midwifery care. This program equips learners to work under the supervision of registered nurses and midwives in hospitals, clinics, and community health settings.
